The offer designated as the winner will be evaluated by adding the score obtained for the evaluation of the technical quality criteria (40 points = 40%) and the score obtained for the financial evaluation, by applying the weighting mentioned above, according to the following formula:  $S_t = S_f + S_c$  where:

Based on the above calculation method, the bidder who meets the mandatory technical and qualification requirements requested and has the highest total score will be declared the winner. If, after applying the award criterion, two or more offers have equal scores, in order to separate them, the contracting authority chooses the offer with the highest score obtained for evaluation factor no 2 (technical quality criteria).
